NOTICE OF FALLS WATER COMPANY'S IPUC APPROVED NEW RATES

On December 14, 2023, the Idaho Public Utilities Commission (IPUC) issued Order No. 36027 addressing the rate case filed by Falls Water Co., Inc. on May 15, 2023. The new rates are effective December 15, 2023, and they will be reflected beginning on the January 2024 billings. The rate increase represents a 28.8% increase of Company revenues.

The new approved rates have a three-tiered usage block to encourage conservation of water. The rates for Taylor Mountain (TM) and Falls Water (FW) customers are combined into the same tariff based on meter size. Morning View (MV) customers base rates are still based on lot size, but usage is based on the 1" meter rate allowance in the three-tiers. The new rates are shown below:

An example of a billing calculation for a customer with a $\frac{3}{4}$ " meter using 25,000 gallons in a billing cycle, the first 8,000 gallons is included in the first-tier block minimum charge of \$22.50. The second-tier block rate will be used to bill the next 16,000 gallons at 0.64 per thousand gallons for \$10.24. The third-tier block rate will be used to bill the next thousand gallons of the 25,000 gallons at \$1.439 per thousand for \$1.44. The total billing charge is \$22.50 plus \$10.24 plus \$1.44 for a total bill of \$34.18.
