

On August 29, 2025, the Idaho Public Utilities Commission (IPUC) issued Order No. 36745 addressing the rate case filed by Falls Water Co., Inc. on January 30, 2025. The new rates are effective September 1, 2025 and will be reflected on the September 2025 billings for the billing cycle beginning August 15, 2025 and ending September 15, 2025.

The new approved rates have a three-tiered usage block to encourage conservation of water. The rates for Taylor Mountain, Falls Water, and Morningview customers are combined into the same tariff based on meter size. The old and new rates are shown below:
